Objective and mandate of the WG

- Review annually a list of proposals for REF projects submitted by Forum members, ECHA Secretariat, the Commission and the Stakeholder Organisations accredited by ECHA (ASOs)
- Prioritise the subjects by applying Forum's methodology for the prioritisation, selection and management of REF projects
- Draft a recommendation proposing the subject for the next REF project and pilot projects

Prioritisation of REF-11 proposals

- The WG collected 10 new proposals for REF projects submitted by Forum members (8), ECHA (1) and ASOs (1)
- WebEx meeting took place on 6 May 2021 to review all proposals
- Some similar proposals were combined
- Some proposals were rejected for not fulfilling mandatory criteria

Enforcement of SDS to check the conformity with requirements of new Annex II.

 REACH Article 31, 32, 34, 37 and Annex II REACH (Regulation (EU) 2020/878)

Proposal for pilot project

Enforcement of the placing on the market and use of Dichloromethane in paint strippers and NMP

- Article 67 of REACH restrictions:
 - Entry No. 59 restriction on placing on market and use of paint stripper containing greater than 0.1 % Dichloromethane.
 - Entry No. 71 restriction on N-Methyl-Pyrrolidone (NMP)
 - Art. 31 REACH
 - CAD and CMD directives




Enforcement project REF-12

Biocide Enforcement project 2 (BEF-2)

- Controls of biocidal products under both the BPR and under national transitional measures.
 - Check of active substance
 - Check of authorisation (if required)
- Modules on Article 95 (supplier of active substance), advertisement, labelling, chemical analysis.
- A section with special focus on disinfectants.
- Operational phase in 2022



Enforcement project BEF-3

- Timeline: 2024 (preparatory phase), 2025 (operational phase) and 2026 (reporting phase)
- ECHA ASOs are invited to submit proposals for Harmonised Enforcement Projects of the BPRS (BEF)
- Deadline for BEF-3 proposal is in April 2023
