

## **Post-employment decisions regarding senior managers**

In accordance with Article 16(3-4) of the EU Staff Regulations, the Agency shall report on its duty to prohibit senior officials, during the 12 months after leaving the service, from engaging in lobbying or advocacy vis-à-vis staff of their former institution for their business, clients or employers on matters for which they were responsible during the last three years in the service.

To this end, the Agency publishes the conclusion of its assessment of applications by senior managers to engage in new occupational activities.
