ECHA PUBLISHES AN UPDATED INTERMEDIATE LIST OF PRE-REGISTERED SUBSTANCES

An updated version of the Intermediate List of Pre-registered Substances was published yesterday on the ECHA website. It contains over 50,000 substances which were pre-registered by 1 November, one month before the deadline of 1 December 2008. The purpose of the intermediate list is to allow Downstream Users of chemicals a possibility to determine whether substances of their interest are already preregistered. A country breakdown of pre-registrations and company sign-ups in REACH-IT is also available.
