Transfers within the budget

Key messages

The Management Board is invited to take note of the budget transfers, carried out since the previous notification, under the responsibility of the Executive Director and detailed in the Annex 1 of this document.

Background

ECHA's Financial Regulation provides that the Executive Director may transfer budget appropriations (a) from one title to another, up to a maximum of 10% of appropriations for the year shown on the line from which the transfer is made, and (b) from one chapter to another, and from one article to another, without limit. Furthermore, the Executive Director shall inform the Management Board as soon as possible of all transfers made.

b) On 23 May 2017, transfer within REACH/CLP Title 1 – Staff - to cover travel allowances paid to staff members. As the budget lines for salaries, (Chapter 11) are provisional by nature and the initial budget needs are established on the basis of the Establishment Plan, there is an inherent uncertainty in this planning (for example, related to the grades of entering into service, turnover and family allowances of the newcomers). The cost estimates can be more closely assessed only later during the budget year when the entitlements and other variable costs of the recruited staff are known.

The amount was transferred from budget line 1113, which had surplus funds resulting from fewer than estimated SNE posts being filled.
