- Plugin available in IUCLID and IUCLID Cloud
- Assists you in preparing your IUCLID dossier
- Carries out validations on datasets and dossiers to verify that information is given correctly
- Validation report lists all failed automated rules together with failure descriptions for each
- Additional manual verifications done by us are not displayed in the Validation assistant







- Use Validation assistant before you submit to minimise failures
  - Check your substance dataset before your dossier is created to correct any failures
  - Check final dossier before submitting it
- Never submit your dossier if there are failures given by the Validation assistant
  - Your dossier will fail business rules or completeness check





## Validation assistant in IUCLID

- Access substance dataset
- Right-click the dataset and select `validate'
- Fill information requested by the tool in the next steps

#### Take home messages



- Use the Validation assistant to check if you give all expected information in your dossier
- Correct all failures that appear in the Validation assistant report
- Do not submit your dossier before all the failures are corrected
- We perform additional checks that the Validation assistant cannot predict
