## On an authorisation of SANYTOL FRESH biocidal product family through mutual recognition in Latvia

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **GRUPO AC MARCA S.L.** on 25<sup>th</sup> January 2017 concerning an authorisation of **SANYTOL FRESH** biocidal product family through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **SANYTOL FRESH** biocidal product family developed by the reference Member State – France.

Therefore, in accordance with Article 34 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (regulation 528/2012) LEGMC authorises the **SANYTOL FRESH** biocidal product family on the basis of mutual recognition process.

The authorisation holder for SANYTOL FRESH biocidal product family in Latvia is:

**SANYTOL FRESH** biocidal product family contains active substance **hydrogen peroxide** (CAS No 7722-84-1; EC No 231-765-0) at the concentration **1.5** %.

The authorisation number of **SANYTOL FRESH** biocidal product family shall be indicated on the label of the biocidal product.

The authorisation of **SANYTOL FRESH** biocidal product family is granted on the following terms:

- Product type: PT2 Disinfectants and algaecides not intended for direct application to humans or animals, and PT4 – Food and feed area;
- Target organism bacteria, yeast and fungi;
- Use area: for Meta-SPC 1 hard and soft surface disinfection in Commercial premises (Food, Industrial and Institutional areas), Households / private areas (Domestic areas) and for Meta-SPC 2 and 3 - hard surface disinfection in Commercial premises (Food, Industrial and Institutional areas), Households / private areas (Domestic areas);
- Users: non-professionals and professionals;



- Product description: ready-to-use liquid;
- Product stability: shelf life two years.

The authorisation applies only to the **SANYTOL FRESH** biocidal product family in the composition, form and packing for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the **SANYTOL FRESH** biocidal product family should be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of regulation 528/2012;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

**GRUPO AC MARCA S.L.** as the authorisation holder shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18<sup>th</sup> April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.* 

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **SANYTOL FRESH** biocidal product family through mutual recognition may be re-opened for review before the 20<sup>th</sup> April 2030.

Additionally, LEGMC would like to inform that **GRUPO AC MARCA S.L.** is fully responsible of the content of the biocidal products as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask **GRUPO AC MARCA S.L.** to notify the above mentioned information down to supply chain.
