On an authorisation of GENERATION MIX through mutual recognition

Latvian Environment, Geology and Meteorology Centre (LEGMC) is the Competent Authority for implementation of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*. On 4th July 2017 LEGMC received the application for an authorisation of **GENERATION MIX** (other trade name: 342 Mix) through mutual recognition in sequence submitted by LIPHATECH.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **GENERATION MIX** developed by the reference Member State – United Kingdom.

Therefore, in accordance with Article 33 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products LEGMC authorise the **GENERATION MIX** on the basis of mutual recognition process.

The authorisation holder for **GENERATION MIX** in Latvia is:

LIPHATECH.

GENERATION MIX contains 0.0025 % (w/w) of *difethialone* (CAS No. 104653-34-1, EC No. not applicable) as active substance.

LEGMC assigns the authorisation number for biocidal product GENERATION MIX:

LV/2017/MR/033

The authorisation of GENERATION MIX through mutual recognition is valid until 31st August 2020 based on reference Member State – United Kingdom – decision.

The authorisation number shall be indicated on the label of the biocidal product **GENERATION MIX**.

The authorisation of **GENERATION MIX** through mutual recognition is granted on the following terms:

- Product type: it is only authorised for use as a product type 14 – rodenticides: *Rattus norvegicus* (brown rat), *Rattus rattus* (black rat) and *Mus musculus* (house mouse);
- Users: professional and non-professional;
- Product description: ready-to-use bait;
- Product stability: shelf life up to 5 years;
- Use area: indoors use and outdoors around the building;
- Packaging size: packaging sizes and materials are indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the biocidal product **GENERATION MIX** in the composition, form and packing material for which the first authorisation is granted by reference Member State to **GENERATION MIX**.

The information on the label (and if applicable an enclosed instruction of use) of the **GENERATION MIX** should be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*,
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006*,
- all other relevant legislation shall be applied.

LIPHATECH as the authorisation holder shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council*.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **GENERATION MIX** through mutual recognition may be re-opened for review before the 31st August 2020.

Additionally LEGMC would like to inform that LIPHATECH is fully responsible of the content of the biocidal product **GENERATION MIX** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask LIPHATECH to notify the above mentioned information down to supply chain.
