## **Whereas**

- (1) Pursuant to Article 59(3) of Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) the European Chemicals Agency (hereinafter referred to as 'The Agency') received from Member States six Annex XV dossiers for substances which in their opinion meet the criteria of substances of very high concern (SVHCs) set out in Article 57 of REACH.
- (2) On 01 September 2023, the Agency invited all interested parties to submit comments on the Annex XV dossiers, as stated in Article 59(4) of REACH.
- (3) The interested party commenting period for all substances ended on 16 October 2023.
- (4) In accordance with Article 59(5) of REACH, the deadline for Member States or the Agency to comment on the identification of the substances as SVHCs was 31 October 2023.
- (5) The Agency did not receive or make any comments on the identification as SVHC for the following substance:

- (6) Therefore, this substance is identified as a substance of very high concern for the reasons set out in the relevant support document of this substance. Pursuant to Article 59(6) of REACH the Agency shall now include this substance in the Candidate List for eventual inclusion in Annex XIV to REACH.
- (7) The Agency received comments on the identification as SVHC for the following substances:

- (8) Thus, pursuant to Article 59(7) of REACH the dossiers related to these substances were referred to the Member State Committee (MSC).
- (9) The MSC unanimously agreed via written procedure, which closed on 29 November 2023, that the following substances meet the criteria set out in Article 57 of REACH for identification as SVHC.

- (10) Therefore, these substances are identified as substances of very high concern for the reasons set out in the relevant support documents of these substances.
- (11) As the substance dibutyl phthalate is already listed on the Candidate List, this entry shall now be updated, pursuant to Article 59(8) of REACH, to reflect its additional intrinsic properties of concern.
- (12) Pursuant to Article 59(8) of REACH the Agency shall now include the substances 2,4,6-tri-tert-butylphenol and Oligomerisation and alkylation reaction products of 2-phenylpropene and phenol in the Candidate List for eventual inclusion in Annex XIV to REACH.
- (13) The Member State Committee at its 84<sup>th</sup> meeting unanimously agreed that the following substances meet the criteria set out in Article 57 of REACH:

Pursuant to Article 59(8) of REACH the Agency shall now include these substances in the Candidate List for eventual inclusion in Annex XIV to REACH.

1. The following substances are identified as substances of very high concern meeting the criteria under Article 57 of REACH:

- 3. Pursuant to Article 59(10) of REACH the Agency shall on 23 January 2024 publish and update on its website the Candidate List for eventual inclusion in Annex XIV to REACH with the entries referred to in paragraph 1 above.

## 4. Entry into effect

This decision shall take effect from 23 January 2024.
